I. SEAL USAGE IN CATALOGS

A. Pick the Correct Label: [check all that apply]

- High Velocity Rain Resistant and Impact Resistant Louver – Enhanced Protection

B. Placement of Label: [check all that apply]

- If the catalog contains all listed products, the label shall be used on the outside cover.
- If the catalog contains both listed and unlisted products, the AMCA Label shall not be used on the outside cover.
- On the same page of a catalog as the performance ratings of the listed product

II. QUALIFYING STATEMENT ADJACENT TO THE LABEL [check all that apply]

- In catalogs containing ratings of listed products, the following statement shall be printed prominently and immediately adjacent to the reproduction of the AMCA Listing Label:

“(Listee's name) certifies that the (product designation) shown hereon (or herein) is approved to bear the AMCA Listing Label. The ratings shown are based on tests and procedures performed in accordance with AMCA Publications and comply with the requirements of the AMCA Listing Label Program.”

- If label is for a Wind Borne Debris Impact Resistant Louver, the following statement shall be shown immediately adjacent to the label:

“The AMCA Listing Label applies to Wind Borne Debris Impact Resistant Louvers.”

- If label is for a High Velocity Rain Resistant Louver, the following statement shall be shown immediately adjacent to the label:

“The AMCA Listing Label applies to High Velocity Rain Resistant Louver Louvers.”

III. CATALOG IDENTIFICATION

- Catalogs containing performance ratings of licensed products should have a unique catalog identification reference (e.g. Catalog No. XXX Rev. 1), and should be dated (e.g. November 2004) on the outside front or back cover.
- Where ratings are on separate sheets or on loose leaf that may be removed from the cover, each sheet or loose leaf should be identified and dated as above.

IV. ADDITIONAL REQUIREMENTS

A. Required with Submittal

- Test data as outlined on the back of the LP-5 form
- Results of test(s), corrected to standard air density (air density not required for impact resistance listing)
- Performance curves of the test results in accordance with the test standard (N/A for impact resistance listing)
- Dimensional drawings of each size of the product line
- Photograph of each test setup
- Proposed catalog
